Have standardized date labels been adopted by food manufacturers?





Three Studies

- 1. A between-subjects in-person design in Columbus
 - Evaluate several commercially packaged products
 - No person saw more than a single date phrase
- 2. A National online replication
 - Used pictures of the products from #1
- 3. A national online with-in subject design
 - Same pictures from #1 & #2
 - Changed the evaluation technique so a single person exposed to an array of date phrases
 - Featured more dates per product in a list form



Some Results




- Sell by is a commonly observed phrase printed on clamshells of lettuce
- One day 'past' the date about 40% of national respondents intend to discard the product





Change the Phrase




- 'Best if used by' is the preferred FMI/GMA phrase for such a product
- One day 'past' the date virtually identical intended discard rate





Avoid this Phrase




- 'Expires on' is sometimes observed
- This phrase increases intended discard
 - by about 5 percentage points (45% 40%) or
 - A 12 percent increase (45/40 = 1.125)





The Role of Education




- Read information about phrases and their meanings
 - Took a quiz
- Decreases intended discard for 2 of the 3 phrases
 - Strongest effect for FMI/GMA phrase
 - 5 pp's or 12% improvement





What a Difference a Day Makes!



- Evaluating item one day earlier cuts intended discard by half or more
 - Even without education
- It is unlikely that quality degrades that much in a single day

Other Products

- Largely similar trends and findings
- 'Expires on' drives higher discard than other phrases
 - o 3 pp to 5 pp more
 - 'Sell by' the next highest in intended discard, but smaller impact than 'Expires on'
- Little systematic difference across other phrases
- Education lowers intended discard
 - In all products, from 1 pp (milk & chicken) to 5 pp (cereal)
- Days are the big movers
 - Day-before to Day-of: 8 pp (cereal & bread) to 15 pp (milk) difference
 - Day-of to Day-after: 10 pp (cereal) to 27 pp (milk) difference





Two Effects of Implementing New Labels




- 1. Change the phrase
- 2. Push back the date to reflect appropriate date for use rather than sale
- If only the phrase changes
 - Impact will be much smaller
- Phrase standardizing will facilitate education
- Scope for additional reductions if firms can push back dates








2018 National Study

- 33% 'Best if used by'
- 11% 'Use by' used in all categories Other Phrases:
- 'Best by' (20.6%)
- Just a date (15.5%)
- 'Sell by' (9.4%)
- 'Best before' (8.4%)
